## The PBSA Is Involved In Washington

PBSA members visit Washington each year for Advocacy Day. In 2019, members met with Senator Ron Wyden and discussed the lifecycle of a background check. Experiences like this help lawmakers understand the importance of background screening, especially when it comes to topics such as making criminal records available to Consumer Reporting Agencies (CRAs).

## The PBSA Intervenes On Your Behalf

A great example of this stems from the Arkansas court system. Changes to their operating procedures caused several courts in the state to start refusing requests for important data that would be used in background checks.

As of April 2018, eight courthouses in Arkansas were denying CRAs access to data. PBSA members got involved by:

- · Sending pre-litigation demand letters.
- Requesting access to data based on the Freedom of Information Act (FOIA) and the First Amendment.
- Offering to find ways to make it easier for courts to share data.
- · Failing all other attempts, initiating legal actions.

Their involvement has made a positive difference. As of July 2018, only 2 courthouses were refusing to provide data.

In addition to state laws, the background screening industry is regulated by a federal law called the Fair Credit Reporting Act. The team at Backgrounds Online studies relevant laws to help ensure we are fully informed and prepared for compliance.
