Our audit is conducted by A-LIGN, a highly trusted and respected security and compliance solutions provider. Their audit includes the suitability of relevant controls we have in-place and the operating effectiveness of those controls over a 6-month period.

After each audit, we have received an unmodified opinion, which means they did not ask us to make any changes. The unmodified SOC 2 reports we receive provide a detailed comparison of our controls against the high standards established by the American Institute of Certified Public Accountants (AICPA). Our audit confirmed that we meet the stringent criteria established for the Trust Services Principles of Security and Confidentiality.
